YVONNA SESSIONS LINCOLN is Ruth Harrington Chair of Educational Leadership and Distinguished Professor of Higher Education at Texas A&M University, having served previously at Vanderbilt University and the University of Kansas. She is the coauthor, editor, or coeditor of 13 books, including *Naturalistic Inquiry* and *Effective Evaluation* (with Egon G. Guba), and the first, second, and third editions of the *Handbook of Qualitative Research* (with Norman K. Denzin). She is currently working on both the *Handbook of Critical and Indigenous Methodologies*, with Norman Denzin and Linda Tuhiwai Smith, and a series of papers and articles proceeding from FIPSE and NSF contracts to assess user perspectives on academic and digital library services.

MICHAEL K. McLENDON is Assistant Professor of Public Policy and Higher Education, Peabody College, Vanderbilt University. His research focuses on policy, politics, and governance of higher education, particularly higher-education policy adoption in the states. His recent research projects include studies of performance-accountability mandates for higher education, the determinants of state reform of higher-education governance, policy innovation and diffusion in state postsecondary systems, and the impacts of state-mandated openness on the governance of public higher education.

JAMES C. HEARN is Professor of Public Policy and Higher Education, Peabody College, Vanderbilt University. His research and teaching focus on postsecondary education policy and organization. In addition to his work on mandated openness, he has recently investigated trends toward marketization and performance accountability in postsecondary-education policy, finance, and management. Professor Hearn is a past recipient of the Distinguished Research Award of Division J of the American Educational Research Association. In 2005, he was named a TIAA-CREF Institute Fellow.

LAURA W. PERNA is Associate Professor of Education at the University of Pennsylvania. In addition to college access and choice, her research also examines equity in faculty reward systems. She is the 2003 recipient of the Association for the Study of Higher Education's 2003 Promising Scholar/Early Career Achievement Award. She holds a Ph.D. in Higher Education and M.P.P. in Public Policy from the University of Michigan, and B.A. in Psychology and B.S. in Economics from the University of Pennsylvania.

MARTIN J. FINKELSTEIN is currently Professor of Higher Education at Seton Hall University. He received the Ph.D. in Higher Education from SUNY at Buffalo in 1978. He has since held faculty appointments at the University of Denver; Teachers College, Columbia University; and the Research Institute for Higher Education, Hiroshima University, Japan. He has served since 1988 as a Member of the National Technical Advisory Board, National Study of Postsecondary Faculty, U.S. Department of Education, and most recently as Codirector, Project on the Future of the American Faculty, Claremont Graduate University. His major publications include *The American Academic Profession: A Synthesis of Social Scientific Inquiry Since World War II*. Baltimore: Johns Hopkins University Press, 1998. His new book, coauthored with Jack Schuster, will be published by the John Hopkins University Press in 2006.

GABRIEL KAPLAN is an Assistant Professor of Public Affairs at the University of Colorado's Graduate School of Public Affairs in Denver, Colorado. His interests lie in the behavior and decision making of public and nonprofit organizations.
